5. Should have participated in orientation/ refreshers courses/ workshops /FDP/ Soft skills/ Dev.Prog/ Research Methodology Workshops
6. Has to his/her credit at least 2 publications in UGC listed journals.
7. Earned good self appraisal assessment through commitment and participation in various college activities.
